Introduction

ContourGlobal Limited (the 'Company') together with its subsidiaries (the 'Group') is a private company, domiciled in the United Kingdom and incorporated in England and Wales. It is the holding company for the Group whose principal activities during the period were the operation of wholesale power generation businesses with thermal and renewables assets in Europe, Latin America, United States of America and Africa, and its registered office is:

The Company is the ultimate parent entity for the Group with respect to the Country by Country Reporting (the 'CbC Reporting') for the calendar year ended 31 December 2025 (the 'reporting period').

The Group develops, acquires, operates and manages wholesale power generation businesses on four continents. It focuses on both underserved or niche markets and developed markets and evaluates projects based on individual merit pursuing greenfield, brownfield as well as acquisition opportunities as they arise. The Group actively collaborates with governments, multilateral financial institutions, manufacturers, contractors and other power and non-power industry participants to provide innovative solutions to the challenge of providing clean, reliable electricity.

Basis for Preparation

The CbC Reporting is prepared based on the Group's 2025 IFRS financial statements and further supplementary information related to the individual entities of the Group. There are certain immaterial differences between the Group IFRS financial statements and the data presented in the CbC Reporting, which mainly result from the adopted methodology for CbC Reporting. Further information about the presented data is provided in the Glossary.

Revenues – Related Parties:	Revenues generated from transactions with related parties, being entities included in the consolidation group of the Company.
Profit before tax:	IFRS-based profit before tax of the Group entities in the relevant jurisdiction.
Income Tax Accrued:	Current tax recognized for the reporting period, excluding prior-period adjustments to current tax and withholding tax expense on intra-group transactions (negative values are current tax expenses, positive current tax credits).
Income Tax Paid:	Payments or refunds of taxes imposed on income or profits effected in the reporting period. The taxes paid or refunded in the reporting period may also relate to past periods (negative values are taxes paid, positive tax refunds).
Accumulated earnings:	Pre-consolidated accumulated earnings of the Group entities in the relevant jurisdiction.
Number of Employees:	Average number of employees on a full-time equivalent basis during the reporting period.
Entities	Entities of the Group are presented in the country where they are tax resident. Stateless or tax transparent entities are presented in the country where their profit or loss is included in the taxable profit/loss of another group entity.
