

ENERGÍA EÓLICA S.A. COMPLETES PRIVATE OFFERING OF \$204 MILLION SENIOR SECURED GREEN NOTES DUE 2034

Lima & New York - Energía Eólica S.A. ("Energía Eólica") announced today that it has successfully completed its private offering of \$204 million aggregate principal amount of its 6.000% senior secured green notes due 2034 in connection with its two wind power projects in northwestern Peru: Cupisnique, with 83.180 MW of installed capacity, and Talara, with 30.855 MW of installed capacity. The notes were sold pursuant to Regulation S under the Securities Act of 1933. The obligations under the notes are secured by a first-priority security interest on all of Energía Eólica's existing and future assets.

Energía Eólica S.A. used the net proceeds of the notes to repay and terminate its senior secured credit facility for the projects, repay certain affiliate loans, make a subordinated intercompany loan, pay engineering, procurement, construction and development costs relating to the projects, provide initial funding for reserve accounts under the notes and pay fees and expenses related to the offering.

About Energía Eólica S.A.

Energía Eólica is a corporation existing under the laws of Peru and an indirect subsidiary of ContourGlobal L.P. ("ContourGlobal") a global developer and operator of wholesale electric power generation businesses. Energía Eólica owns two wind power projects with total installed capacity of 114.035 MW and related interconnection equipment in northwestern Peru.

About ContourGlobal

ContourGlobal is an international power-generation company with approximately 4000 MW in operations or under construction in 21 countries and on four continents. ContourGlobal's 1650 employees manage, own and operate a portfolio of 58 power plants utilizing a wide range of fuel types and technologies including renewable energy production based upon hydro-electric, wind, solar and biomass, as well as an extensive fleet of conventionally powered thermal power plants.

In Latin America, ContourGlobal LATAM has 1,626MW under development, construction and operation in Brazil, Colombia, Peru, Mexico and the Caribbean. Its current portfolio consists of 774MW in operation, 437MW of wind projects under construction in Brazil, and 415MW of wind and hydro projects under development in Mexico and Brazil. 2

Contour's wind portfolio in Latin America includes Cupisnique and Talara, in Peru, with a total of 114MW of installed capacity, the Asa Branca Wind Complex, in Brazil, with 160MW of installed capacity and the Bonaire wind farm, in Bonaire, with 11.1MW of installed capacity.
